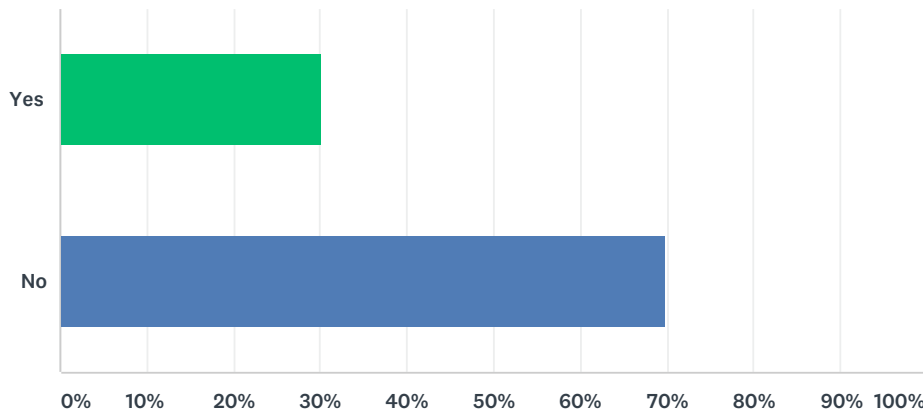


Q1 Have you ever offered any part of a property you own for short-term accommodation rental?

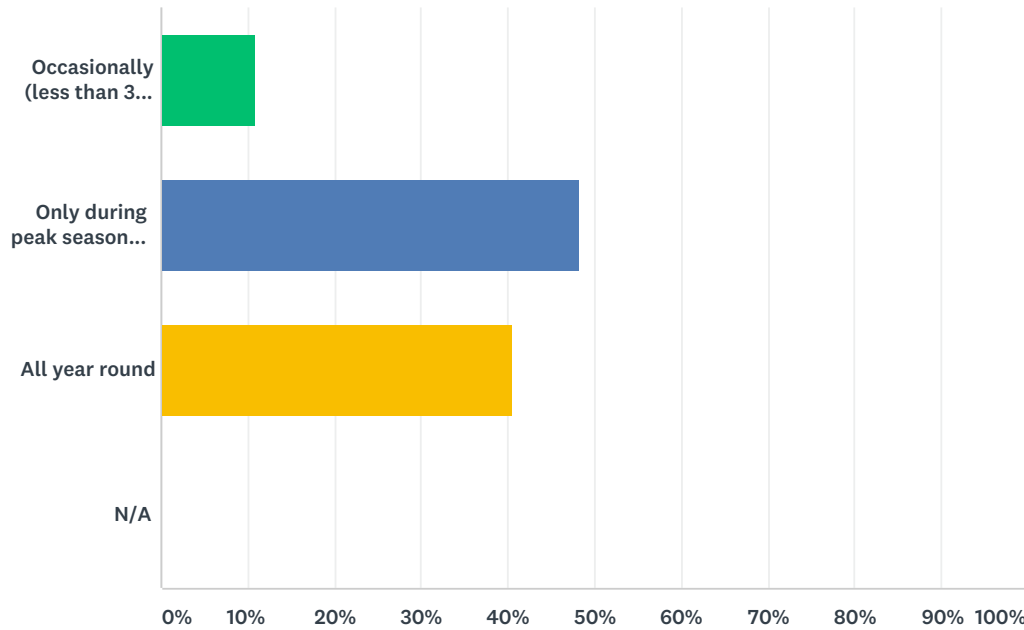

Q2 How often have you rented your property?

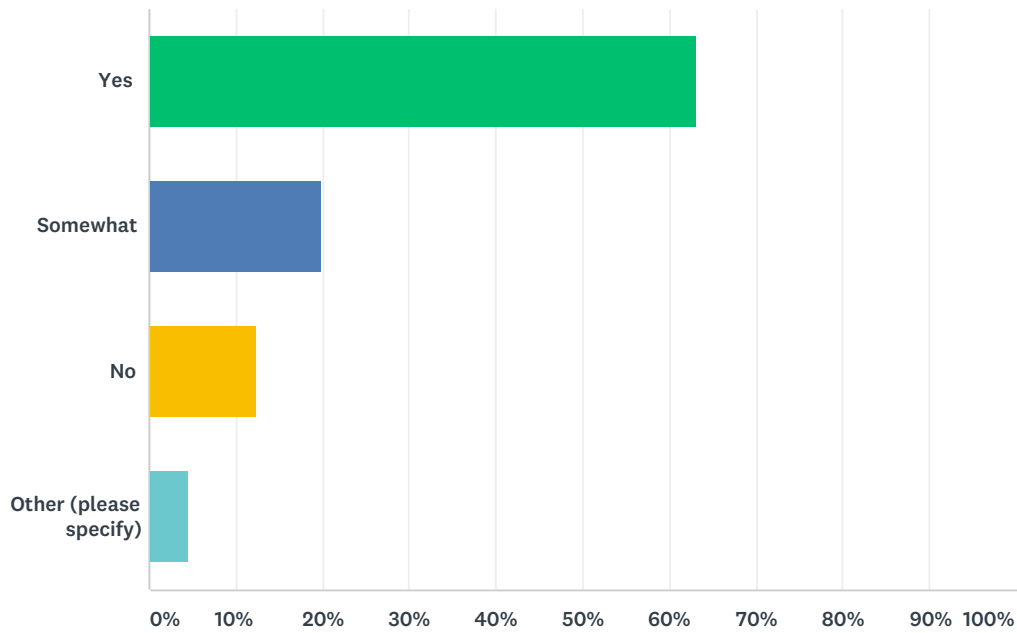

Q3 Offering short-term accommodation rental(s) as a business is an important source of annual income for my household. Do you agree?

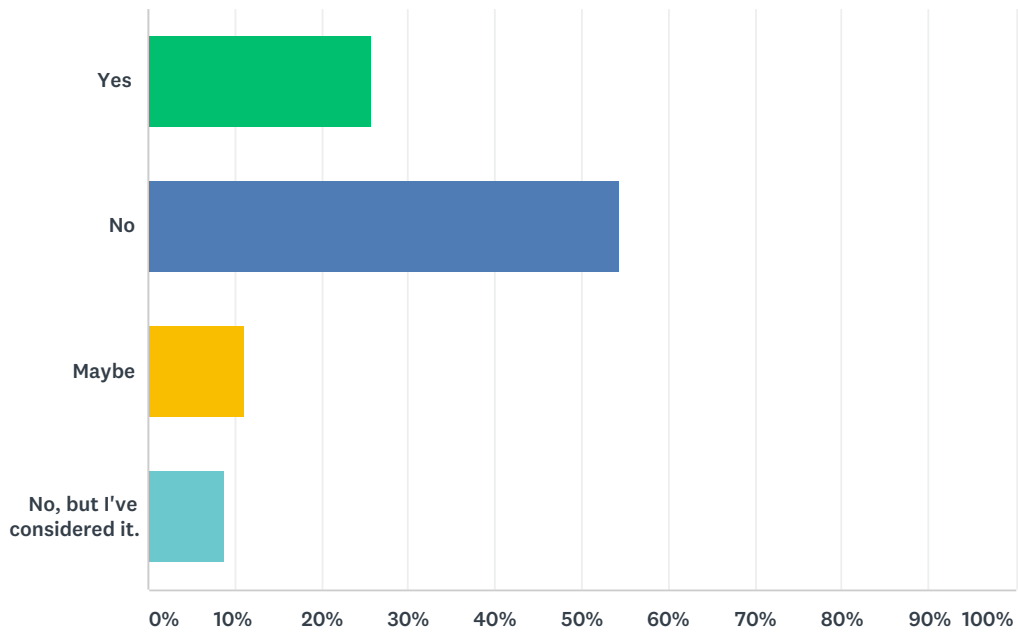

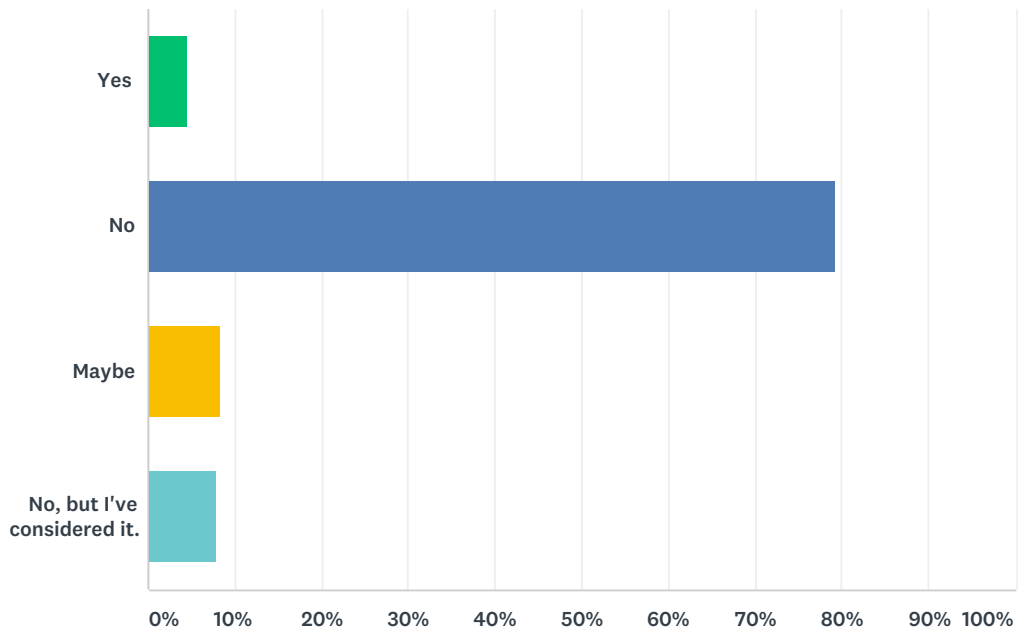

Q5 Do you plan on purchasing a property for the purpose of offering short-term accommodations?

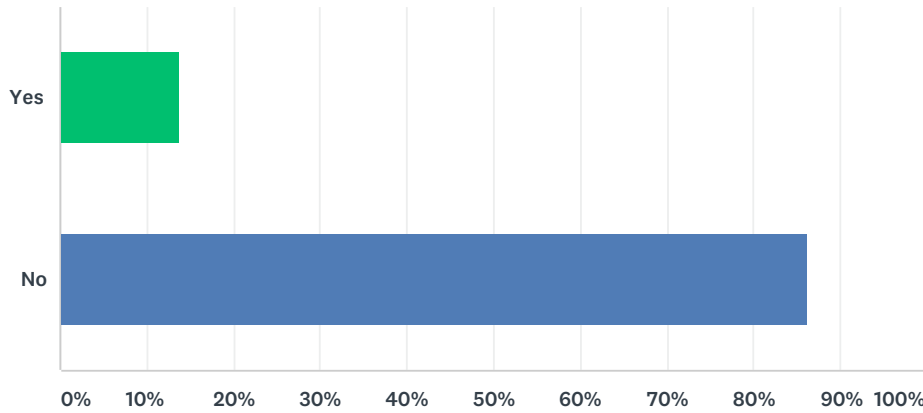

Q6 Do you own any additional properties other than your primary residence that are used as a short-term accommodation rental?

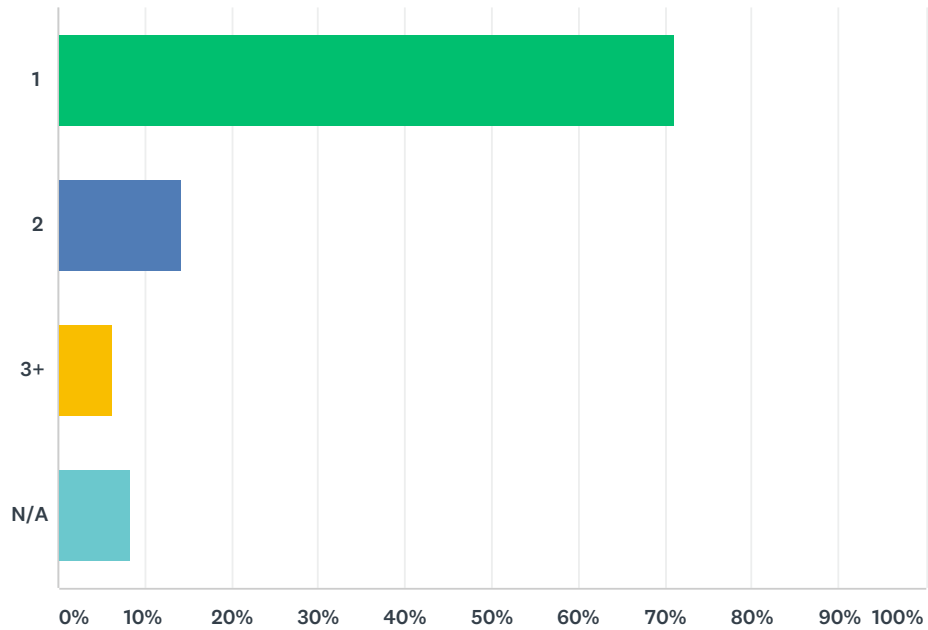

Q7 How many short-term accommodation rental properties do you have?

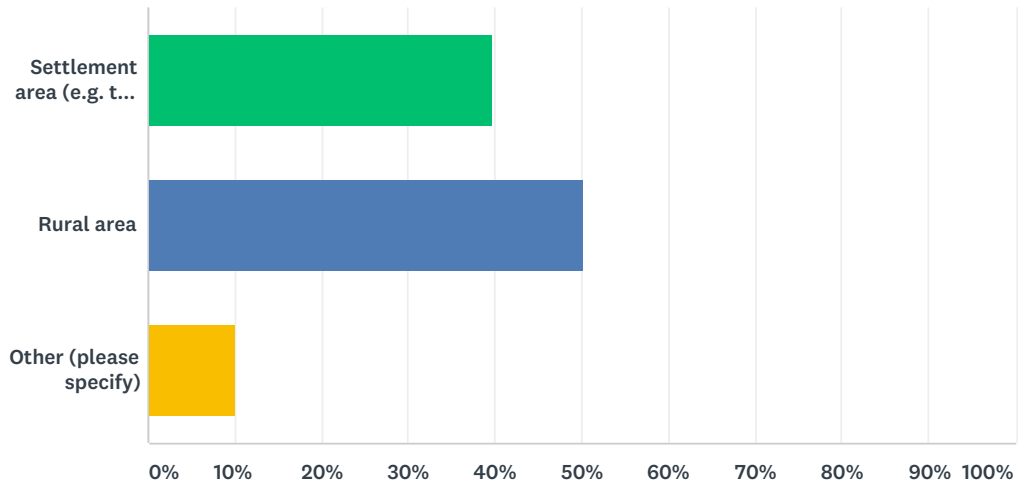

Q8 Where is your short-term accommodation rental located?

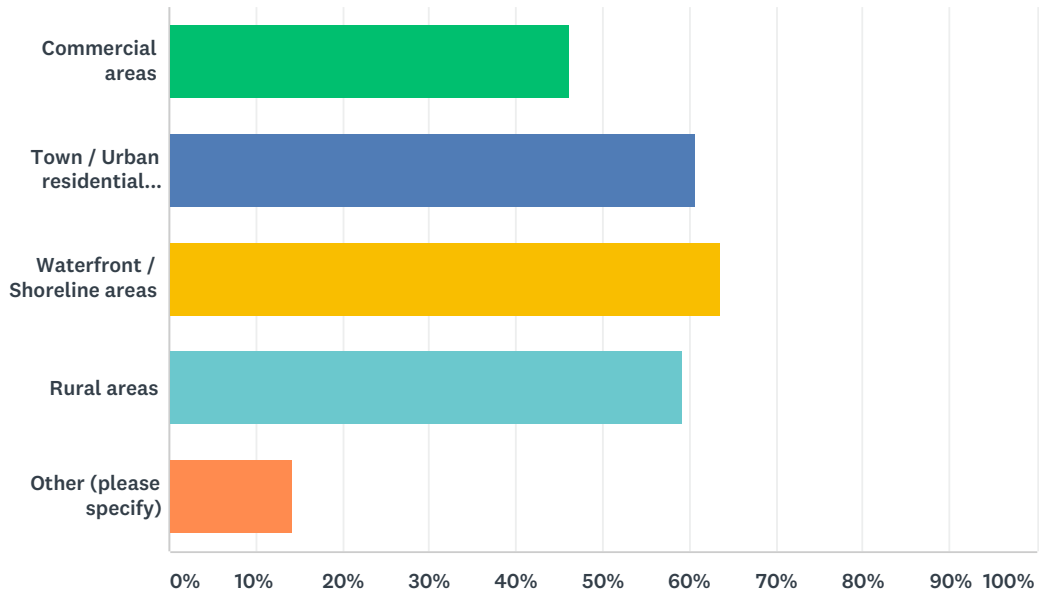

Q9 Which areas do you feel are appropriate for the location of short-term accommodations? Select all that apply.

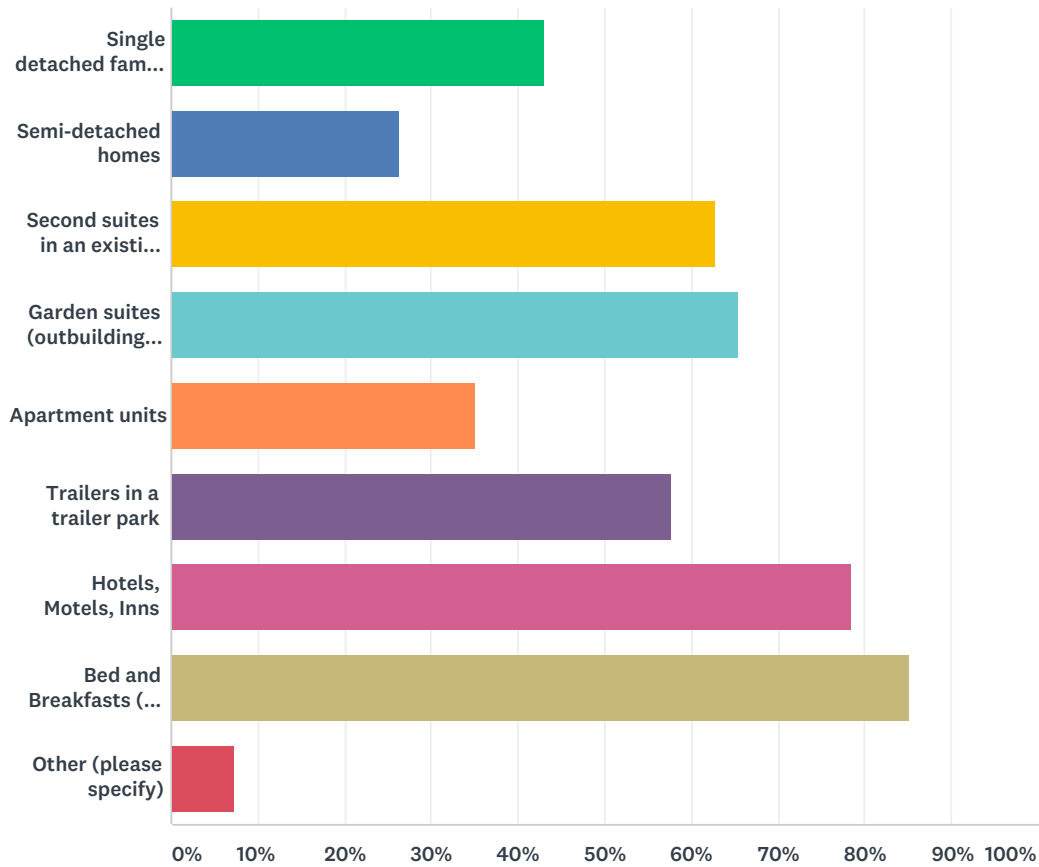

Q10 In your opinion, which of the following forms of dwellings or properties are best suited for short-term accommodation rentals? Select all that apply.

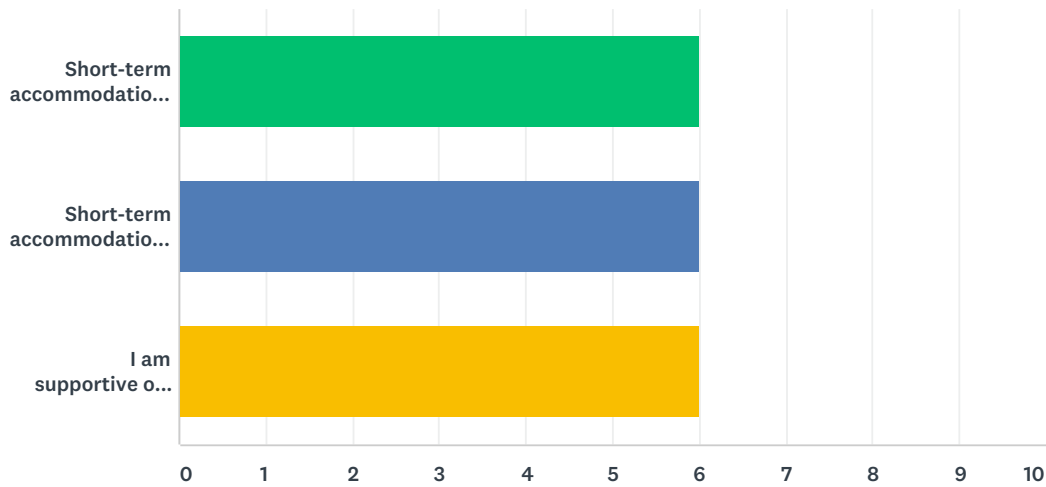

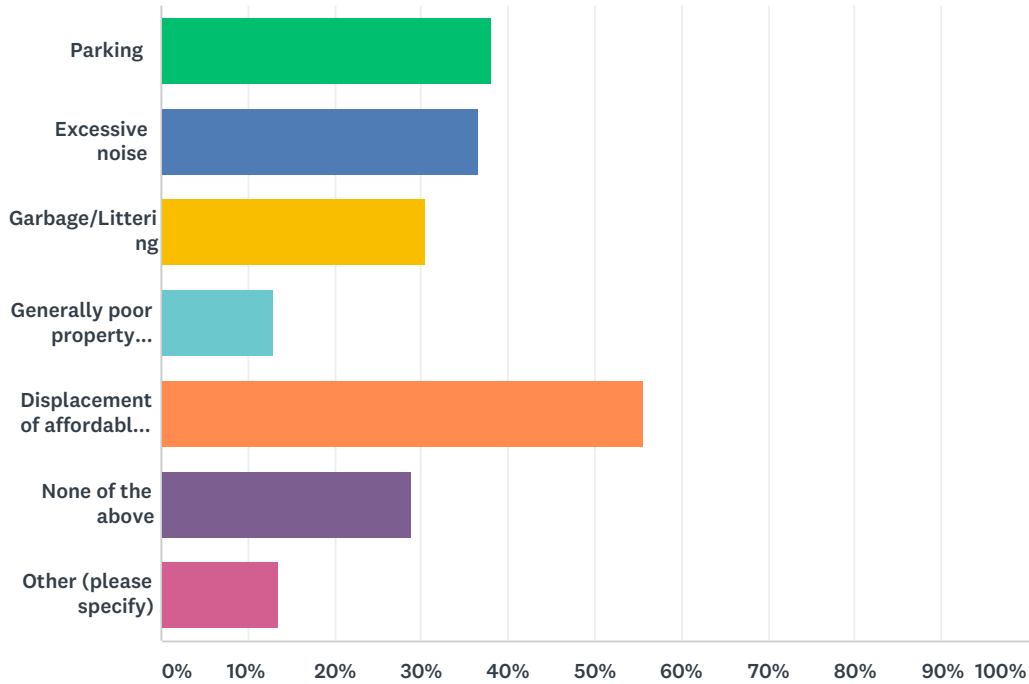

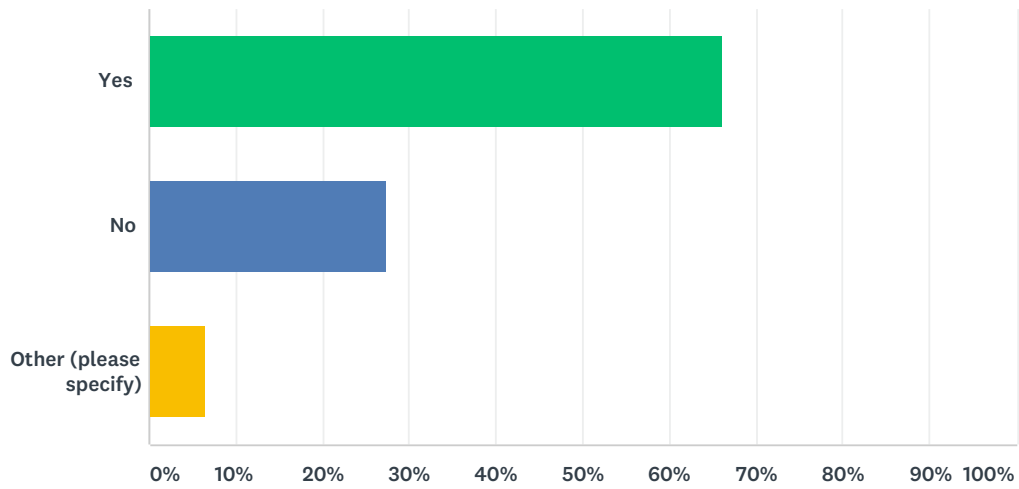

Q13 Do you think a form of municipal regulation is needed for short-term accommodation rentals in The County?

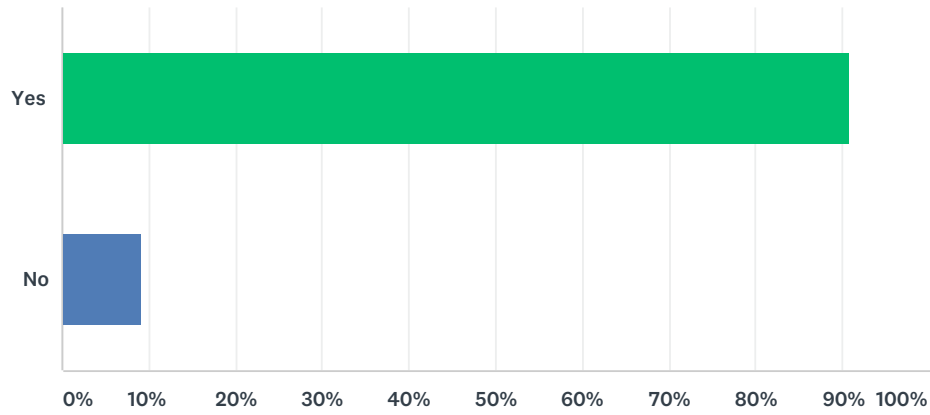

Q14 Are you a resident of The County?

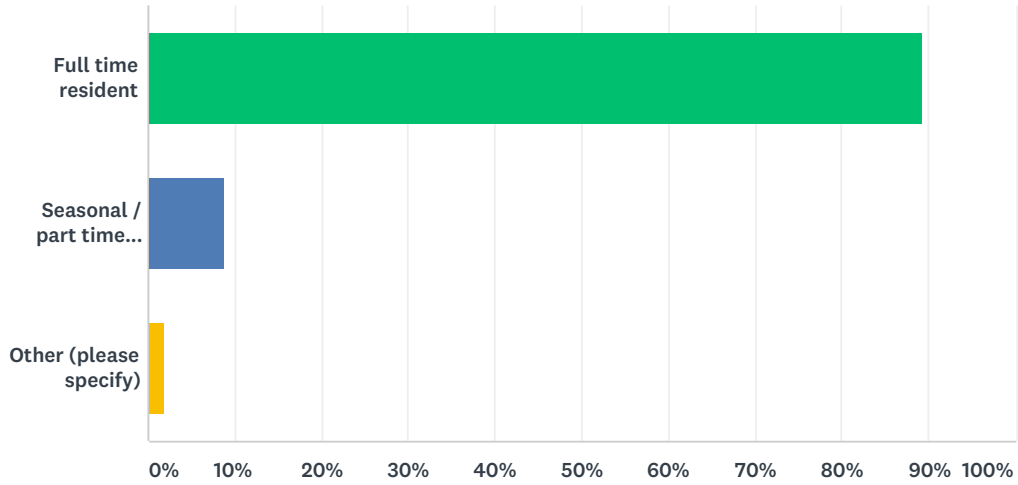

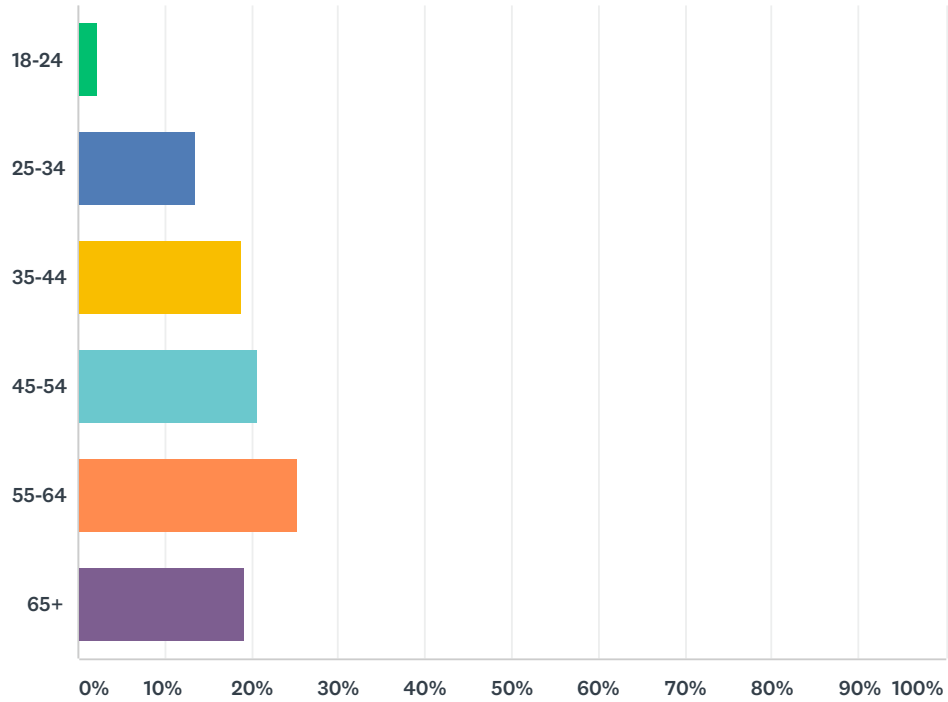

Q16 How old are you?

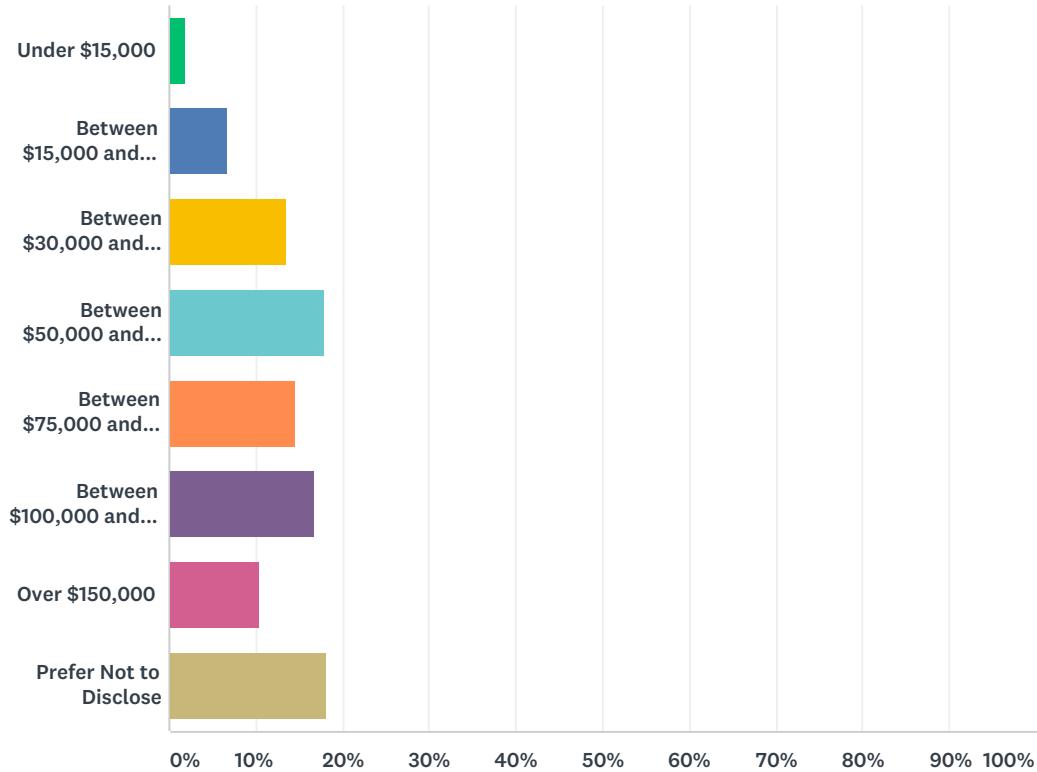
