Among the many changes in this legislation, the Bill replaces the CIHA tool in the Planning Act with a revised Minister's Zoning Order (MZO). The new MZO, which is essentially the same as the CIHA, has some additional submission requirements. Since the introduction of the new legislation, County staff have been in contact with staff from the Ministry (MMAH) to convert the prior CIHA request that had been submitted in January 2024 to be an application under the new process.

The purpose of this letter is to ensure you are aware that County Staff, with support from the County's consultant Stantec, are preparing a resubmission to the Ministry to meet the new requirements, and advance the request previously approved by Council. We anticipate filing the resubmission in the coming weeks.
